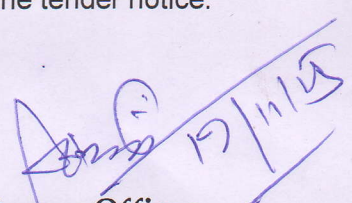
Technical Bid

TERMS & CONDITIONS REGARDING PURCHASE POLICY:

1 **Bid Information:**

A) Bidder must quote for all the items in the Financial bid. Quotation for the single item/partial quotation will not be considered and the tender will be rejected in that case.

B) The rate quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.

2 **Evaluation of Quotation:** The Purchaser will evaluate and compare the quotations determined to be substantially responsive stage wise. Firstly, Technical Bid will be evaluated based on and thereafter Price Bid for technically qualified bidders will be evaluated for selection of vendor.

3 **Award of Contract:** The purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive both technically and commercially for all the instruments mentioned in tender documents. Purchaser reserves the right to reject any or all the tender, wholly or partly, without assigning any reason thereof and shall not be bound to accept the lowest bid.

4 **Warranty:** The vendor shall be fully responsible for the comprehensive onsite warranty in all respect of the Products, including spares and services for a period of three years from the date of installation. Warranty will be effective from the date of joint installation Report.

5 **Manufacturer's Authorization:** Document in support of Manufacturer/Dealer and Service Provider has to be submitted along with the tender paper. If the bidder is not the manufacturer, proper manufacturer's authorization and warranty from manufacturer is required.

6 **Time Schedule:** The supply and installation work must be completed within 15 days from the date of receipt of the Work order.

7 **Validity of offer:** A bidder should spell out in the tender that it shall remain valid for a minimum period of forty five days from the date of opening of the tender and during this period, the bidder shall not be entitled to revoke or cancel its offer.

8 **Place of delivery:** Department of Chemistry, Raiganj University, Raiganj, Uttar Dinajpur, PIN -733134.

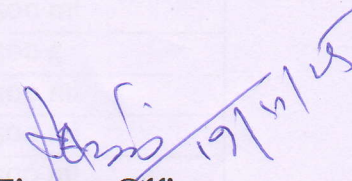
9 **Payment Schedule :** Payment to be made after delivery, installation and certification by the HOD / Coordinator, Department of Chemistry.

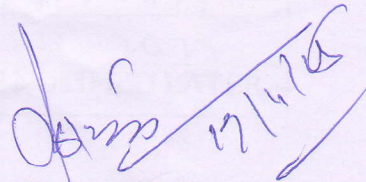
